

## **TERMS AND CONDITIONS FOR “WIN THE ULTIMATE MOTHER’S DAY GIFT FROM LARSEN JEWELLERY” 2021 PROMOTION**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “**WIN THE ULTIMATE MOTHER’S DAY GIFT FROM LARSEN JEWELLERY**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on VIC local time.

### **ELIGIBILITY**
